InfoCert provides the Remote Digital Signature Service (the "**QES Service**"), as a company registered in the list of qualified certifiers held by the Agenzia per l'Italia Digitale and as a Qualified Trust Service Provider (QTPS), according to the EU Regulation N. 910/2014 od 23/07/2014.


